## **Presentation: Natural Tours - P Gotty**

Piripi Gotty: Otatara / Tuhoe – Phil has for a long time been involved in Transport/Tourism. Asking the Taiwhenua to be included in Tourism with him and would like their backing. He is passionate about the people and wants to see this take off here in Napier

Phil tabled his qualifications to support his Licensing and has been a driver for 40 years. He is also an Owner Driver with half Price Taxi Cabs. Has his PSL. He would be happy to run with the Taiwhenua with Tourism, Shuttles, Transport. He is able to utilise the Nimons bus Fleet at his disposal. Any other drivers would need to be endorsed by Nimons.

He has had a positive response from some of the Key Stakeholders in regarding promoting Maori Tours, Guides Training. The possibilities of expanding on his Tourism can include buses out to the Marae, Maori Arts & Culture, including Kapahaka. Needing to utilise all the events that are coming, Matatini, Waitangi Day events etc. He sees potential in our Premises being a possible base for ½ Price Cabs.

P Gotty introduced Hugh Tareha who runs the Waiohiki Arts Centre and is well known to many board members. P Gotty would promote and include Maori businesses like this within his Tourism Bus Tours. A meeting with the Tourism Roopu will sort the finer details.

# **Presentation 2: Construction & Building**

<u>HORVATH CONSTRUCTION:</u> Adam Horvarth presented to the Board, an overview of his Building business. His Business incorporates all roles within the building from the Surveying, Labouring, Electricity, Drainage & Plumbing, Building, Roofing, Interior Designing, Their need is the whenua to build on Adam is interested in joining with Maori to assist with employment & on the job training for dedicated iwi members who seriously want to develop skills under this Career path



#### **PAN PAC**

Combined Support of all hapu within Ahuriri is required to Not allow Pan Pac to continue their proposal to extend their effluent out 2000 metres at sea. : There is already evidence of pollution in the inner waters of our Bay, transferring the problem out 2000 metres where it cant be seen doesn't take the problem away.

#### **SALE of Taiwhenua:**

Some discussion over whether we sell ,as is or do the repairs and renovations to bring the buildings up to standard. Unless we can find services that are not a double up of what is currently being offered, or alternatively, rent space within the Taiwhenua to create income we will have no option but to sell.

The most urgent repairs relate to the stairway and the Electricals. Both are very old and need to be made safe. General feeling was to hold off for now until we have had the property revalued and ascertain a Sale Price. NKII will be kept informed of our status.

<u>Ahuriri District Health</u>: That we approach them with a view to re-establish the health services for our people. Is the Taiwhenua able to support them to get through any issues so we can establish a new entity under our umbrella?

**MANA AHURIRI**: Our Board want to meet with MAI and discuss some of the following to be able to take information back to our Marae.

- 1. Our long term plans to work together for the future
- 2. What the Taiwhenua will look like after settlement???
- 3. What does MAI see as our role (As Taiwhenua)?
- 4. Who does MAI see as the Mandated Spokespersons for Ahuriri?

### **IM LOCAL**

Is a group representing Youth who are undecided of their Gender: Gays, Homo-sexual, Lesbian, Mafradites. IM Local are asking for support to provide a venue (whether it be for a set time) for these people affected by these issues to be able to meet and confront their differences in a safe environment. Community Acceptance: This kaupapa was supported by the Board.

<u>Maungaharuru Tangitu Trust</u> had offered Tangoio Marae to host this Years ANZAC day and asked for support from the Taiwhenua for this day. However since this meeting was held this has now been returned to the 28<sup>th</sup> battalion To host.
